Big Changes Come to Foundation Web Site

Visitors to the Wabash Valley Community Foundation's web site will soon see some big changes thanks to a recent revamping of the site. The biggest change is actually the larger size of the web page itself.

"We need our web site to be a valuable tool for donors, grant seekers and anyone looking to the Foundation for charitable giving assistance," said Executive Director Beth Tevlin. "We wanted to update and modernize the look of the site and at the same time streamline the navigation."

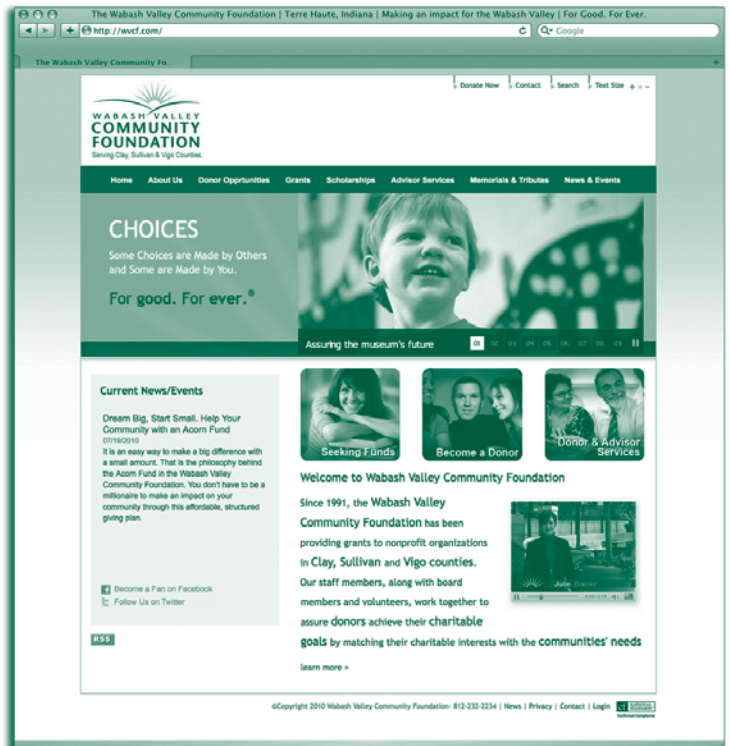
Jill Coleman of MillerWhite Marketing, who designed the new site, said the first step was to take advantage of a larger screen size, allowing room for more visual elements and larger type.

Coleman explained, "The new site has more points of entry into the site for easier use. The main navigation is now provided through dropdown menus arranged across the page - About Us, Donor Opportunities, Grants, Scholarships, Advisor Services, Memorials & Tributes and News & Events. We've provided quick links for making donations, finding Foundation contact information and searching for information. There is also an option to increase the text size for viewers who need a larger size type. In the left hand column people will get the most up-to-date Foundation news and announcements."

Tevlin said, "We've enhanced the site with the addition of a rotating banner featuring photos and stories. It's not only more appealing visually, but it's also more informative, because it highlights our actual donors, funds and grantees. And we can now feature our new video, narrated by board

member Julie Baesler. It's an overview of the Foundation and how it impacts communities in our three counties."

"Viewers will love that our updated site is better organized and easier to navigate," Tevlin added. "It is now easier to make an online gift, find a grant application or scholarship application. With the larger screen area and type, it's much easier to read and more inviting."

She wrote instructional guidelines for the teaching of keyboarding for elementary teachers. She also served as an officer and building representative for the Vigo County Teachers Association.

Becky enjoys music and is a member of the Farrington Grove Chorale and the Memorial United Methodist Church Choir.



Intern Helping Foundation Complete Re-Certification

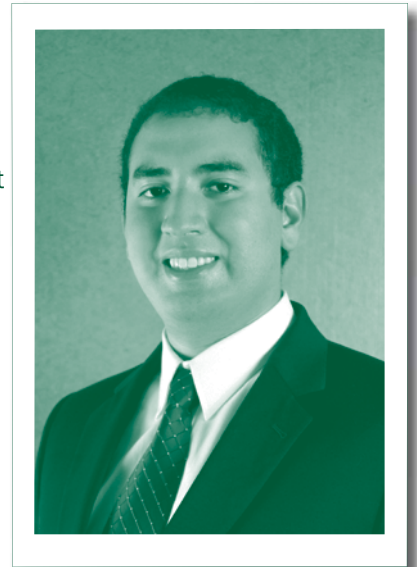
Mark Ellis is assisting the Wabash Valley Community Foundation with preparations for national and state standards re-certification. Ellis, a Rose-Hulman Institute of Technology graduate student in engineering management, is interning with the Foundation thanks to a program established by Lilly Endowment Inc.

The Community Foundation Internships (CFI) program, makes it possible for Indiana community foundations to engage interns from Indiana colleges and universities. CFI is a pilot program that helps build healthy community foundations while providing college students with real-life work experiences in Indiana. The CFI program will allow the Wabash Valley Community Foundation to hire up to three college interns at a time over the next two years (*one per county*). Funding from Lilly Endowment will provide the salaries for full-time summer interns and for part-time interns during the academic year.

Mark's undergraduate degree from Rose-Hulman is in *biomedical engineering*, and he has another year of work to complete his Master's degree in engineering management. He also has studied at universities in Australia, New Zealand and Germany.

"I saw the Foundation internship advertised through Rose-Hulman's career services website," Mark said. "I liked the idea of working for a not-for-profit foundation, since it was a foundation that helped to fund my undergrad studies."

In assuring that the Foundation conforms to the 2010 standards, Mark is incorporating revisions required by the Pension Protection Act of 2006. Every change he suggests requires approval from the Board of Directors.



Executive Director Beth Tevlin said the Foundation will be hiring two more interns for the fall. "We would like to find students who can help us develop our social media presence and who have writing abilities to work on our various publications," she said.



Give Today to Endow Dictionaries Forever!

Did you know that if you give just \$1,000 today to the Wabash Valley Community Foundation, every student in one third grade classroom in Clay, Sullivan or Vigo county will receive a dictionary each and every year - forever!

In collaboration with local Rotary Clubs, the Community Foundation has delivered nearly 14,000 dictionaries to local third graders since 2004. In 2009, the Community Foundation provided more than 1,863 dictionaries – 1,236 in Vigo County, 365 in Clay County and 262 in Sullivan County. Rotary Club members will tell you that passing out dictionaries generates excitement in all the third grade classes.

In the past, the dictionaries have been funded by grants from one endowment fund whose benefactors had a particular interest in educational causes. As the need for supplemental school funding increases, those funds are being funneled into other necessary projects. The answer to continued funding for dictionaries, then, is the Community Foundation’s Wabash Valley Dictionary Project Endowment Fund.

With an endowment fund, donations provide perpetual support; the donations are invested, and the dictionaries are purchased with the proceeds of the investment. The donations never get spent, and the investment continues to grow, providing the funding for dictionaries year after year. For every third grade classroom, it takes \$1,000 to endow the purchase of a dictionary for each student every year.

Meadows Elementary School now has all of its dictionaries funded, thanks to the Karen J. Wright Memorial Fund, established in memory of Mrs. Wright, a Meadows Elementary third grade teacher who passed away in 2008. Friends, colleagues and former students made donations in her memory to the Community Foundation. Executive Director Beth Tevlin suggested to Karen’s husband Jim that the donations would endow dictionaries for the third grade students at Meadows Elementary School. Karen’s family felt that would be an appropriate memorial to Karen’s dedication.

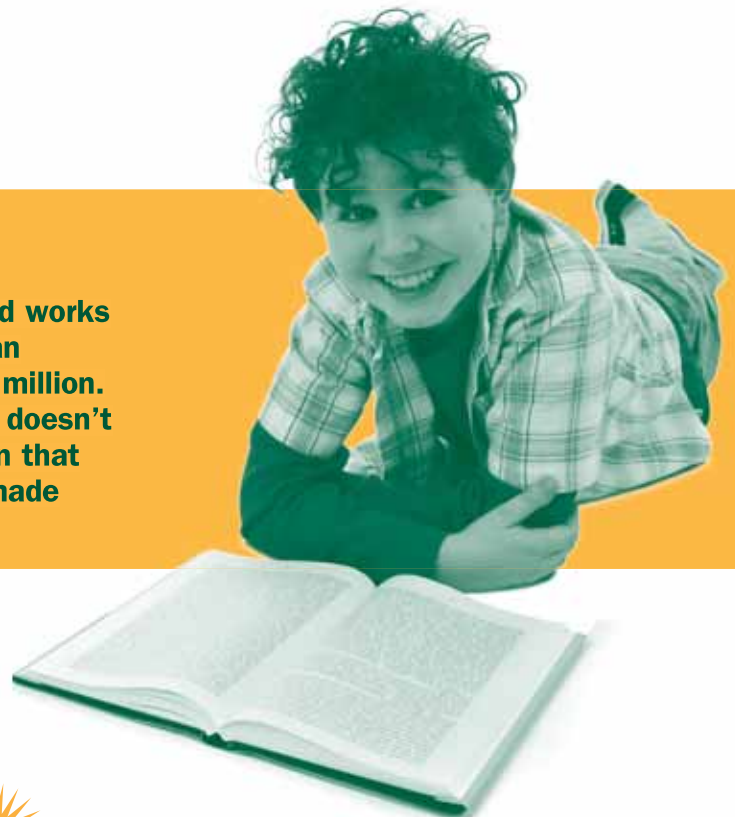
In Vigo County, 17 more elementary schools remain to be endowed, many with multiple third grade classes. Clay County has eight elementary schools and Sullivan County has six. In addition, there are eight private elementary schools in the three counties.

So how can you ensure that dictionaries will be provided to an entire class? You can encourage your civic group to raise the funds. Perhaps your family can designate the money they would have spent on birthday and holiday gifts for one another to go toward the Dictionary Project Endowment Fund. Or, you and a group of friends could donate to the Dictionary Project Endowment Fund in memory or honor of a beloved friend, family member or teacher.

How an Endowment Works

As an example of how an endowment fund grows and works over time, in 1992, Delmar and Betty Jones set up an endowment in the Foundation with a donation of \$1 million. Today, that endowment contains \$1.02 million. That doesn’t sound like a great return until you understand that in that 18-year period, from that fund, the Foundation has made grants of nearly \$935,000 to assist the community.





Exline is Sullivan County's First "Volunteer of the Year"



Sullivan County Community Foundation presented its inaugural "Volunteer of the Year" award to Teresa Exline.

Exline was instrumental in organizing the Sullivan First Presbyterian Church's Community Kitchen mission in 2000 and has been involved in planning and organizing for the approximately

15,000 meals that have been served there. The Foundation awarded the charity a \$2,500 donation in honor of Exline's achievement and awarded her a clock in recognition of her time volunteering."

Exline credited the church's minister Paul McGlasson with inspiring the effort to set up the mission. However, it was McGlasson who nominated her for the Foundation's volunteer award, citing her dedication, organizational skills and kindness as reasons for the success of the mission's efforts to feed people in Sullivan who are in need. The Community Kitchen is a project of the Church and serves one hot, nutritious meal a week, free of charge to any and all takers without any restrictions.

Exline organized the first Souper Saturday Cook-Out event last spring to help raise \$10,000 in honor of the mission's 10th anniversary. Proceeds were to be split between purchasing food for the charity's weekly meals and adding to its endowment fund within the Community Foundation. She was quoted as saying, "Our ultimate goal is to build the endowment account to the point where it generates enough revenue to fully cover the operating costs of the Community Kitchen."



Agencies Preparing Requests for "Better Together" Grants

Working together for one cause, nonprofit agencies in Clay, Sullivan and Vigo counties have until October 1, 2010, to apply for the Wabash Valley Community Foundation's "Better Together" grants.

Under its "Better Together" initiative, the Foundation will fund up to \$50,000 toward one or more projects or programs that address a common issue.

In developing the initiative, the Foundation recognized that many local nonprofit organizations serve similar populations and share similar challenges related to capital improvements, transportation, program expenses, audience/client engagement, and staffing. Through "Better Together," cooperating agencies can tackle common challenges with significant funding.

In Phase 1 of this two-phase initiative, collaborative groups had the opportunity to request a Planning Grant of \$2,000

to assist with expenses related to building a cooperative partnership. The Foundation funded five planning grants. Receiving a planning grant is not a requirement to participate in Phase 2 of the initiative.

According to Kelli Miller, Program Director, "Nonprofit organizations are working together to focus on a broad spectrum of issues including strengthening families, enhancing Autism Spectrum Disorder education and awareness, renovating a historic African American church for use by a conflict/abuse prevention program, and building ramps and providing transportation to enhance accessibility for seniors, among others."

In Phase 2, going on now, collaborators are to submit their formal proposals for Implementation Grants by October 1st. The Community Foundation will grant up to \$50,000 to fund one or more projects or programs.
